**LEVEL II EXAMINATION RESULTS AS APPROVED ON 19<sup>TH</sup> AUGUST, 2021**

Valuers Registration Board is a public body corporate established by the Valuation and Valuers Registration Act (Cap. 138). The Board's main functions include registration of Valuers for valuation practice, evaluation of academic and practical qualification for purposes of registration, encouragement of educational advancement of Valuers and control of valuation practice.

Following its establishment in 2018, the Board started offering professional training and conduct examinations for purposes of registration in three levels. Professional Level I examination was conducted in January, 2021 and the results approved on 18<sup>th</sup> May, 2021. Professional Level II examination was conducted on 17<sup>th</sup> July 2021 for eighty one (81) Valuers with the results now out and hereunder displayed.

Note that for those whose results are not displayed, will have to contact Registrar's Office in order to get their results after fulfilling examination candidacy requirements as per Board's Examination Rules and Regulations.
